Terms and Conditions - Redraw Facility

If you have repaid early, so long as there is no default under the loan agreement, you may redraw any amount for any purpose other than a purpose which is illegal, fraudulent, or related to either an illegal or fraudulent purpose. In these terms and conditions and your loan agreement, a prohibited use of loan money includes trading drugs, organised crime, fraud, terrorism, and any kind of criminal activity including money laundering. The amount you redraw must not be less than the minimum amount, if any, specified by us from time to time and must not be more than the total amount you have repaid early and for which cleared funds have been received, however if we allow a redraw in excess of the total amount you have repaid early we may nonetheless debit your account with the amount of the redraw.

We may review, suspend or cancel the redraw facility at any time without notice. Redraws will be processed as we decide from time to time. While you have one or more sub-loans, any redraw will be made from the account specified by you, or if no account is specified, the account determined by us.

While the whole of the loan is fixed rate, any redraw will establish a new variable rate sub-loan. While you have one or more sub-loans and one of those loans is fixed rate, any redraw will be made from the variable rate sub-loan specified by you or if no sub-loan is specified, the sub-loan selected by us.

If there is one or more person who is a party to this loan or facility, redraw withdrawal transactions can be authorised by one of you and each of you can bind the other. Each person is liable individually for each redraw withdrawal transaction, whether or not you are aware of it, or authorised the transaction, in addition to each of you being jointly liable with each other.
